

# **Terms and conditions of participation B&B HOTELS Germany: Team D – Tickets for the Winter Paralympics 26**

## **1. Organizer**

The organizer of this competition is B&B Hotels Germany GmbH, Altkönigstraße 10, 65239 Hochheim am Main (“B&B Hotels”).

## **2. Participation in the competition**

2.1 By participating in this competition, you accept these terms and conditions.

2.2 All members of the B&me loyalty program run by B&B Hotels are eligible to participate. Each B&me member may only participate in the competition once.

Participation is free of charge and independent of the purchase of goods or services.

2.3 To participate in the competition, the B&me member must declare their participation on the B&B Hotels website <https://www.hotel-bb.com/en/teamgermany/raffle> (“participant” (m/f/d)). To do so, they must enter their name and email address in the participation contact field. Only if a B&me member account with the name and email address exists will the participant take part in the competition.

2.4 The competition begins on February 6, 2026, and ends on February 22, 2026, at 11:59 p.m. The winner will be determined by lottery on February 25, 2026, from among all participants.

## **3. Prize**

The prize consists of a trip for two people from March 13 to March 15, 2026, to Cortina d'Ampezzo for the Winter Paralympics. The prize includes two hotel nights in a double room with breakfast (March 13–15, 2026) at the B&B HOTEL Passo Tre Croci Cortina. Travel to the destination is not included in the prize and must be arranged independently. The winner will also receive 2 tickets to each of the following competitions:

Para Alpine Skiing on Sunday, **March 15, 2026**, Tofane Alpine Skiing Center

## **4. Notification of winnings; payment of winnings**

4.1 B&B Hotels will notify the winner by email to the email address stored in their B&me account no later than one day after the draw. The winner and their name will not be published. The winner must confirm receipt of the prize notification within 24 hours as specified in the prize notification. If the winner does not confirm receipt of the prize notification within this period, B&B Hotels is entitled to select another winner by drawing lots.

4.2 Cash payment of the prize is excluded. The travel dates and the competitions to be attended cannot be changed. The prize is not transferable. B&B Hotels is entitled to exchange the prize for another comparable

prize if the original prize cannot be awarded due to circumstances beyond the control of B&B Hotels.

## **5. Exclusion**

5.1 Any violation of these terms and conditions entitles B&B Hotels to exclude the participant in question from participation.

5.2 If the excluded participant is a winner who has already been drawn, the prize may be revoked retrospectively.

## **6. Liability and compensation**

Any liability for damages on the part of B&B Hotels and its organs, employees, and vicarious agents arising from or in connection with the competition, regardless of the legal basis, is limited to cases of intent or gross negligence, to the extent permitted by law.

7.3 Legal basis; purpose and scope of data processing

The legal basis for the processing is Art. 6 (1) lit. b GDPR (performance of a contract).

7.4 Right to object and right to erasure

The information provided by the participant to B&B Hotels in relation to the competition can be updated or deleted at any time at the participant's request.

The collection of the participant's data for the purpose of conducting the competition is essential for the implementation of the competition, which is why a request for deletion will result in exclusion from participation in the competition.

## 7.5 Data security

We take technical, contractual, and organizational measures to ensure the security of data processing in accordance with the state of the art. In this way, we ensure that the provisions of data protection laws, in particular the General Data Protection Regulation, are complied with and that the data processed by us is protected against destruction, loss, alteration, and unauthorized access.

All information that you transmit to us is stored on our servers in the Federal Republic of Germany.

## 7.6 Disclosure of data to third parties

Data will only be disclosed to third parties within the scope of legal requirements.

We only disclose user data to third parties if this is necessary, for example, on the basis of Art. 6 (1) (b) GDPR for contractual purposes or on the basis of legitimate interests pursuant to Art. 6 (1) (f) GDPR for the economic and effective operation of our business. Within the scope of order processing pursuant to Art. 28 GDPR, we use subcontractors for the provision of our services, in particular for the operation, maintenance, and hosting of IT systems. We have taken appropriate legal precautions and corresponding technical and organizational measures to ensure the protection of personal data in accordance with the relevant legal provisions.

## 7.7 Rights of participants

In the case of the processing of personal data, participants are data subjects within the meaning of the General Data Protection Regulation (GDPR) and have the following rights vis-à-vis B&B Hotels with regard to the personal data concerned:

- Right of access (Art. 15 GDPR)
- Right to rectification (Art. 16 GDPR)
- Right to erasure (Art. 17 GDPR)
- Right to restriction of processing (Art. 18 GDPR)
- Right to data portability (Art. 20 GDPR)
- Right to object to processing (Art. 21 GDPR)
- Right to lodge a complaint with a data protection supervisory authority (Art. 77 GDPR)

## 8. Final provisions

8.3 B&B Hotels is entitled to terminate, suspend, or modify the competition prematurely if unforeseen circumstances beyond the control of B&B Hotels arise that make the original implementation difficult or unreasonable for B&B Hotels.
